BMW settled with the FTC for violating the Magnuson-Moss Warranty Act. BMW's MINI division was telling consumers that their warranty was void unless they used MINI parts and MINI dealers to perform maintenance and repair work.

The Magnuson-Moss Act makes **it illegal for companies to deny coverage under the warranty simply because you used an aftermarket part**. The FTC says the manufacturer or dealer must show that the aftermarket part caused the need for repairs before denying warranty coverage.

This is significant to us, because it means that the dealer cannot require any particular brand of motor oil for warranty support. They can require the oil meet particular specifications, but not the brand name. If the engine fails, the dealer has to show that the oil caused the failure before they can deny coverage.

Although each violation can result in a penalty of up to \$16,000, BMW's settlement was a little less severe. For the next 20 years they have to stop saying that you have to use the dealers' parts or service to maintain the warranty or to ensure a vehicle's safe operation or maintain its value, unless they can prove it scientifically. Also, they have to inform owners of their right to use third-party parts and service without voiding the warranty. Harsh.

Gasoline deposits are still a problem.

The Engine Builders Association released two Technical Bulletins concerning fuel additives in the October-December 2015 issue of *Engine Professional* magazine -- ond about intake valve deposits and the other about exhaust valve deposits.

TB2682 describes a multiple-cylinder misfire in 1999 to 2006 4.0L Jeeps. The root cause is exhaust valve deposits. During short-trip driving at low RPM, deposits can build on exhaust valves, preventing their rotation. Winter temperatures prolong warm-up and deposits are more likely to form. The deposits cause the valve to close more slowly, creating the misfire.

Chrysler recommends using their combustion chamber cleaner to remove the deposits. The Engine Builders Association recommends a valve job for a longer lasting repair.

We recommend using Gas-O-Klenz, and occasionally, some spirited driving. Regular use of Gas-O-Klenz will prevent exhaust valve deposits and clean existing deposits. Operating the engine above 3200 RPM for a while will rotate the valves, which helps control deposit formation, and it creates more heat. Deposits are less likely to form on hot surfaces, and heat can actually reduce carbon deposits.

TB 2687 is the Engine Builders Association's recommendation for Top Tier Gasoline for optimal fuel economy, drivability, and emissions control. Top Tier Gasoline is a detergent gasoline specification recommended by Audi, BMW, GM, Honda, Mercedes-Benz, Toyota, and Volkswagen.

The EPA requires detergent in all gasoline because an engine with intake valve deposits will produce more emissions than one without. So, many gasoline retailers use the lowest additive concentration possible to meet the mandate. The required detergent level is too low. Part of the problem is that the EPA's test is run in a 1985 BMW, and fuel systems have changed since then. The detergent level is inadequate, and you only have to go back a few paragraphs for evidence.

Top Tier Gasolines contain 2 to 3 times the amount of gasoline detergent of gasoline using the lowest additive concentration required by the EPA.

Gas-O-Klenz used at the regular rate adds well over 5 times the lowest additive concentration level. It cleans both intake and exhaust valves, and provides storage stability, rust inhibition, combustion chamber clean-up, and injector clean-up for indirect and direct injection engines. Like the Engine Builders Association says, a clean engine provides optimal fuel economy, drivability, and emissions control

Heel warts are still a problem for dairymen.

According to the Milk Development Council, up to 89% of dairy cattle can be infected with digital dermatitis, more commonly known as hairy heel warts. They point out that lameness caused by heel warts is now the second largest dairy cow health challenge, behind mastitis.

Heel warts are severely painful, restricting mobility and feed intake. This, of course, affects milk production and dairy profits. It is estimated that the annual cost of a herd with a 20% infection rate is \$168 per cow. Multiply by the size of the herd, and you can see we are looking at a serious cost.

Heel warts can be controlled over time with copper sulfate foot baths. Many Cen-Pe-Co customers have found that George II makes the powder easier to dissolve into the bath, and increases its effectiveness for quicker control of heel warts.
